## TOWNSHIP OF TILDEN

### FACILITIES USE ORDINANCE

#### ORDINANCE NO. 14

An ordinance to secure the public peace, health, safety and welfare and protection of the environment of and for the residents of the Township of Tilden, Marquette County, Michigan, by regulating the time that Tilden Township facilities may be utilized by the public.

The Board of Tilden Township, Marquette County, Michigan ORDAINS:

#### SECTION I                      NAME

This Ordinance shall be known and may be cited as the "Township of Tilden Facilities Use Ordinance."

#### SECTION II                      PURPOSE

The purpose of this ordinance is to regulate the time Tilden Township facilities may be used by the public.

#### SECTION III                      DEFINITION OF TILDEN TOWNSHIP FACILITIES

Tilden Township facilities are the Township Hall, basketball courts, tennis courts, pavilions, volleyball courts, playgrounds, baseball fields, ski trails, horseshoe courts and ice rink.

#### SECTION IV                      TIME

Tilden Township facilities may be used by members of the public between the hours of 8 a.m. and 10 p.m. This time period may be revised by Resolution of the Township Board. Individuals renting the Township Hall, employees acting in the course of their employment duties, elected officials acting in the course of their official duties, police officers and/or firefighters are not subject to this time regulation.

#### SECTION V                      PARKING

No person may park a motor vehicle at any Tilden Township facility unless the parking takes place in conjunction with use of the facility. Further, a vehicle may only be parked at the Tilden Township facility during the time period in which the facility is open to the public, pursuant to in Section IV above

#### SECTION VI                      LOITERING

No person shall be permitted on any Tilden Township facility after the hours the facility is opened to the public, pursuant to Section IV above.

#### SECTION VII                      PENALTIES

Any person who violates the provisions of this Ordinance shall be deemed to be responsible for a civil infraction and shall be subject to a civil penalty in accordance with the following:

- First offense within a one year period – maximum fine \$100
- Second offense within a one year period – maximum fine \$200
- Third offense or more within a one year period – maximum fine \$500

SECTION VIII      SEVERABILITY

This Ordinance shall become effective thirty (30) days after publication.
